- read the ICoC Articles of Association.
- read and agree to abide by the principles and guidelines in the UN Guiding Principles on Business and Human Rights.
- read and where relevant reflected the UN Guiding Principles on Business and Human Rights in their processes and operations
- auditable processes in place to demonstrate adherence to the Voluntary Codes of Conduct or other principles and Associations to which they may adhere.
- a commitment to play a constructive role which adds value to the SCEG Membership and the objectives of the group.
- a commitment to provide evidence that they are delivering security or other services for clients in complex environments.
- processes in place to demonstrate that they have accredited certification or an intent to be certified against relevant standards including where appropriate ISO 18788 and ISO 28007
